### New officers set to serve on the Board

Deborah Wooldridge is a Professor and the Director of the School of Family and Consumer Sciences and has been at Bowling Green State University for

three years. Her career has taken her to Zaved University in the United Arab Emirates, Southeast Missouri State University, the University of Bahrain, and to government and NGO entities in Oman, Kuwait, Bahrain, the UAE, Dubai, and Abu Dhabi..She has a PhD. in resource management and consumer behavior from Texas Woman's University and a BS and MS in Education from the University of Oklahoma. During her career in higher education she has published, secured international, federal and state funding for research and community partnership projects. Her research interests are cultural and social issues of the family, learning outcomes assessment and curriculum redesign and assessment.

Being involved in the community she lives is important to her. Thus, she has served on the Board of Directors for the Cape Girardeau American Cancer Society and the Easter Seals. Currently she is on the Board of Directors for the Destiny House in Fostoria and on the Cocoon Shelter in Bowling Green. For fun, she spends a lot of time playing and walking her 1 year old Havanese dog, Gia. She loves blues, jazz and classical music. Live theater is another one of her interests, especially drama. Deborah collects Islamic artwork, artwork on and about women, Persian rugs and Native American pottery. She loves to read plays and has begun quilting since moving to Bowling Green.

Jean Gerard is an Associate Professor of Human Development and Family Studies in the School of Family and Consumer Sciences at Bowling Green State University. She holds a B.A. degree in psychology from Oakland University, Michigan and an M.S. and Ph.D. in child and family studies from The University of Tennessee. Her research interests include risk and resilience in adolescence, the impact of marital conflict on children's adjustment, and family policy with a particular focus on child custody legislation. Her teaching interests include adolescent development, family communication, and research methodology. She has a strong commitment to projects that serve women and atrisk youth: she has served as a member on the Cocoon Shelter event planning committee and Women's Initiative-United Way of Greater Toledo and has been involved in community outreach efforts aimed at reducing high risk behaviors among area youth. Jean's hobbies include gourmet cooking, backpacking, and traveling. Her favorite pastime is spending summer afternoons tending to the needs of her garden. An avid gardener, Jean is currently enrolled in the Master

Gardener program sponsored by The Ohio State University Extension, an educational program with an

extensive community service component. Jean resides in Bowling Green with her partner, Fred Coulter, her son, Matt, a freshman at BGSU, and her Labrador Retriever, Max.

Susan Peet is a Lecturer in Human Development and Family Studies in the School of Family and Consumer Sciences at Bowling Green State University. She holds a PhD. in Child Development and Family Studies from Purdue University and a B.S. and a M.S. from Texas Tech University. She has taught graduate and undergraduate courses in human development and early childhood education in a variety of settings over the past 15 years, including programs for military families based in Europe. Susan loves working with college age students and she hopes to continue this work for many years. Issues of parenting and family contributions to children's learning are of prime interest to her. She also is very interested in promoting the professionalization of early childhood learning environments.

Being involved with family and community are important to Susan. Susan parents three active and involved children in Bowling Green, serves on the Board of Directors for the Montessori School of Bowling Green, is parent advisor for the Student Advisory Board at St. Aloysius School in Bowling Green, and is a member of a local investment club. ## New Board member Jeannie Ludlow takes charge of LAF fundraising

**Jeannie Ludlow** is a farm kid from western Indiana who earned a Ph.D. in American Culture Studies in 1992. She is on the faculty of Women's Studies, where she also serves as undergraduate advisor. On campus, she is a member of Honors Advisory Council, the Ethnic Cultural Arts Program committee, the Common Reading Experience Committee, and the Board for the Institute for the Study of Culture and Society. She acts as faculty advisor to two student organizations (NARAL/Pro-Choice BGSU and Pandora's Box) and is a member of Transcendence, the transgender awareness and action organization. Professionally, she is a member of the International Society for the Study of Narrative Literature and the National Women's Studies Association, where she is co-chair of the Social Justice Education Task Force.

Locally, Jeannie is involved in a variety of activist endeavors, including membership on the Board of Directors of the United Christian Fellowship Center and in the local chapters of NOW, NARAL, and the Toledo Take Back the Night planning collective. She has been involved in local environmental and animal rights activism and has worked part-time for ten years at The Center for Choice, an abortion clinic in Toledo. Her research focuses on abortion politics and practices in the U.S.; her most recent article "Sometimes It's a Child<u>and</u> a Choice: Toward an Embodied Abortion Praxis" is forthcoming in the National Women's Studies Association Journal in summer, 2008. In addition, she is a mom and an avid runner and (notso-avid) swimmer. She lives in the aqua/purple/terra cottacolored house on North Main Street in BG with two cats, two dogs, and a sweetheart who is a great cook.

# FROM THE TOP

I have been privileged over the past few years to meet and know Michele Wetherald, current Interim Executive Director of AAUW. She was the person who recommended to the Ohio AAUW president back in 2000 that I be asked to serve as the State's Legal Advocacy Fund Chair because she had been present at the State

Convention's Equity Day that I helped organize as part of the annual state conference. I guess I was the right person at the right time--at least Michele thought so! Then, something similar happened to her: Michele was chair of the Legal Advocacy Fund Board of Directors and by all reports a very effective leader. When the AAUW Executive Director resigned suddenly due to health problems and shortly after her replacement was hired, she, too, had to resign to address serious health problems, there was a leadership crisis at a critical juncture in AAUW's history. With financial losses and membership losses, it became clear that something must be done and quickly. In a bit of a scramble that I can only imagine, the state and association leaders turned to Michele and asked her to serve as the Executive Director for the following year...then another year....

Below are some of Michele's reflections in an email she sent me this week. They state so well the challenges we face as an organization that I want to share them.

"As I keep telling people, this position is 24/7 --- since AAUW is in the midst of major changes. It is critical that AAUW remake itself -- on so many levels --- to ensure its relevance for the future. ... We are not just another social group, and must focus on mission first. That takes leadership and commitment!

I'm so excited you let me know about the March Title IX event (referencing my From the Top column in last month's newsletter)-- *we aren't just their grandmother's AAUW anymore.* While many take Title IX for granted, the number of LAF cases we support each year demonstrates the ongoing need and that while we've "come a long way" .... it's not a completely open door yet. Sports (and equal access to all things related to education) have made such a difference for young women -- especially on campus. I love hearing parents of young girls tell their story about how different life is for their daughters playing sports growing up. Their world will be so much easier than ours --- learning skills we had to learn after we arrived in the workplace!"

I guess I was the right person at the right time in the right place when I was asked to serve as Ohio's chief spokesperson for LAF. Michele was the right person in the right place at the right time to fill the shoes of Executive Director of AAUW when a leadership crisis developed; and I'm so pleased to refer you to another woman who is the right person and the right time to lead our branch efforts in promoting and educating women about the Legal Advocacy Fund (LAF). Jeannie Ludlow, Director of Undergraduate Studies in the Women's Studies Program at BGSU has agreed to fill the slot left open when Marilynn Ward completed two terms as Chair on December 31. For a branch which draws 50+% of its membership from university-employed women, LAF has to be a great comfort! There is NO other source of funding in the U.S. which exists solely to help women and girls seek judicial redress for inequity in

*higher education. PERIOD.* Just on that basis alone, every woman on campus has a reason to join us.

So reach out and ask your friends and colleagues to join AAUW; the more the merrier, for sure, but and the more the more potent and powerful our message! Michele and others working tirelessly at the national level have provided tremendous leadership and invested energy in getting AAUW on track so that it remains truly relevant to women and girls in the years to come. That's why you joined so share that reason with others; we are a MISSION-based organization. We do things to make a difference in the lives of girls and women.

- 2. Home Depot: the registry at the Home Depot is only available on-line. We are listed under first name Cocoon, last name Shelter.
- 3. Elder Beerman: the registry at Elder Beerman is available both on-line at elder-beerman.com, and in the store. We are listed under first name Cocoon, last name Shelter.


