Four Outstanding Women Honored by Branch

In the classic setting of the Bowling Green Woman's Club, after a dinner catered by Carpe Diem of Perrysburg, four women were honored for their outstanding contributions to the Branch and to the community. Many thanks to Julie Fiscus for coordinating the selection process.

Diane Regan presented the first award for Outstanding Community Leader [Non-Branch Member] to Vickie Askins, member and officer

of the Wood County Citizens Opposed to Factory Farms (WCCOFF), who seek a moratorium on Concentrated Animal Feeding Operations (CAFOs) until the effects on humans and the environment can be determined. Regan said Askins was a "great and passionate presenter," and that "politicians don't want to answer the questions she asks, because she asks the hard ones." Askins accepted her award "on behalf of Larry (her husband) and other citizens in [their] group." She also said that WCCOFF will continue their efforts because "our cause is just and we'll keep fighting for it."

Branch member Deborah Wooldridge presented the second award for Outstanding Community Leader, Non-Branch



Member to Michelle Clossick, the Executive Director of the Cocoon Shelter, which will celebrate its 2nd birthday in June. In the past two years, they have provided 1200 hours of advocacy to women and children. Wooldridge said of Clossick, "she has a passion to help women and

children and has developed a theoretical framework based on empowering battered women. Her model for shelters is nationally recognized and is used in shelters across the country." Clossick thanked the Branch members, saying, "so much of what we're able to do comes from the overwhelming, truly overwhelming, support of the community."

Branch member Ellen Dalton presented the award for Outstanding Community Leader, Branch Member, to Evelyn Bachman. Ellen detailed the numerous ways in which Evie has given to the community. She has been a member of the Woman's Club since 1991, serving as Club President and President of the Garden Group. She is an attorney whose areas of practice are family law, wills and estates. For five years she served as Domestic Relations Magistrate for Judge Kurfess. In her community, she served on the board of trustees for the Wood County Hospital. She is currently serving as the Educational Foundation Chair for the BG Branch of AAUW and in 2003, was named Outstanding Citizen (Woman) by the Bowling Green Chamber of Commerce. She has also been a longtime member of AAUW, League of Women Voters, P.E.O. International, the Wood County Bar Association, Ohio State Bar Association, Bowling Green Chamber of Commerce and the First Presbyterian Church.

The award for Outstanding Branch Member, was presented by Julie Fiscus to Deborah Wooldridge. Currently, she is a professor and Director of the School of Family and Consumer Sciences at BGSU. In the community, she is on the Board of Directors for the Destiny House in Fostoria and the Cocoon Shelter in Bowling Green, where she orchestrated the recent gala dinner and silent auctions that raised a significant amount of money for the shelter. She also coordinated the Elder-Beerman Community Day activities for the BG Branch of AAUW and currently serves as the covice president for programming. Wooldridge accepted her award, saying, "I am honored by this – I've only lived here for two-and-a-half years!" She continued, stating how "exciting it is to be a part of (AAUW)," and that is has "helped her to connect to her community and feel at home."

A brief business meeting followed the awards ceremony. Betty Jean Anderson encouraged members to buy raffle tickets for a painting by fellow branch member, Nancy Leetch. All proceeds from the raffle tickets will be donated to the local scholarship fund, which sends two young women to camp BE WISE every year. The slate of 2006-07 officer candidates was approved and will be voted on at the May 3rd meeting.

LEGAL ADVOCACY FUND in ACTION

Wouldn't it be great to live in a society where women and girls had equal access to education and educationrelated benefits? Where women's tenure files were assessed fairly and equitably? Where sexual assault never happened on college campuses? Of course it would, but we don't live in that society—yet. Our donations to the AAUW Legal Advocacy Fund comprise one step toward creating that society. Donations from our local members to the Legal Advocacy Fund make a difference to plaintiffs all over the US. Please do what you can to contribute to our goal of \$475 in LAF contributions, so AAUW can continue to help plaintiffs win cases like these:

Sex discrimination cases at Feather River Community College in California

Two separate claims have been filed against Feather River Community College. Both plaintiffs are being assisted by AAUW. Michele Jaureguito, former director of Upward Bound/Talent Search, made formal complaints that a staff member sexually harassed teen participants and gave them alcohol. She was retaliated against for making the report. L.W., former head coach and faculty member, was wrongfully terminated after criticizing the way the college treated women in funding, selecting, hiring, and compensating coaches for women's sports teams. *Our contributions can help these plaintiffs fight for their own—and all women's—rights to equal treatment and protection from retaliation.*

AAUW praised in Berkeley Labor Law Journal for aiding and supporting victims of employment discrimination

In the *Berkeley Journal of Employment and Labor Law*, a publication from the Boalt Hall School of Law at the University of California, Berkeley, AAUW is given well-deserved credit for its assistance to victims of employment discrimination. This is great recognition of the AAUW LAF's ongoing commitment to equality. *Our contributions make this work not only possible but also visible*.

FROM THE TOP

OK, members--it's time to think of ourselves! Sign up for Equity Day on April 20 at Tiffin and for the State AAUW Convention on April 21 because both days will be filled with mission-based programming related to women's economic security. What could be more important or more basic?! If you read the Adelante Selection this month, you will also be reading what many AAUW members in Ohio and across the Association are reading as we begin to seriously discuss our economic security. Liz Perle's Money, A Memoir: Women, Emotions and Cash is a great read and very thought provoking and will be discussed at Equity Day from 3:15-4:45. The book examines women's attitudes about money, cash, earning, spending, and investing and should lead us to reflect on how our emotional attitudes about money seriously impact both our short and longterm economic well-being as well as that of our family. Earlier that day, the Ohio State AAUW Equity Day program features Financially Fit for Life, a brand-new, just rolled out pilot from the

Association. This program has been developed by the AAUW Leadership and Training Institute with the support of Prudential Financial, and we have the opportunity to be the first in the nation to benefit from it!

April 24 is Equity Pay Day, the day women in the U.S. finally earn what men of similar education, training, and employment earn by the previous December 31! Participate in this day by sending out an electronic postcard to everyone you can think of so that no one can ignore the fact that wage discrimination continues unabated in this country. AAUW's Public Policy Program states that we are committed to supporting "fairness in compensation, equitable access and advancement in employment, and vigorous enforcement of employment antidiscrimination statutes." We must remain committed to bring about equity in these areas because we still only earn \$.77 for every dollar men earn. Part of the reason for this is that occupational segregation continues. Women who still work predominately in "pink collar jobs' will find that their retirements are also reduced, all too often putting them below the poverty.

As author Liz Perle notes we don't feel comfortable talking about money, but if we don't, too many of us are relegated to remain underpaid and facing a life of economic *insecurity* 'til the end. AAUW is taking action in economic areas important to all of us so join in the action! Come to Tiffin on April 20-21 and RENEW your commitment to AAUW by sending in your dues to Joan Gordon, Branch treasurer. There is power in a collective voice.

Gift Registries to support the Cocoon Shelter

The Cocoon Shelter has four registries in area stores for community members to access. Because the items listed are what the shelter most needs, those wishing to help have a convenient way to get such items to the survivors of domestic violence. The registries are at the following stores:

- 1. Target: the Cocoon Shelter has a wish list through Target, which is slightly different than a registry. You can access the wish list on-line at target.com, or at the store at the kiosks located near the entrance. We are listed under first name Cocoon, last name Shelter.
- 2. Home Depot: the registry at the Home Depot is only available on-line. We are listed under first name Cocoon, last name Shelter.
- 3. Elder Beerman: the registry at Elder Beerman is available both on-line at elder-beerman.com, and in the store. We are listed under first name Cocoon, last name Shelter.
- 4. Meijer: the registry at Meijer can be viewed online or in the store. We are listed under first name Cocoon, last name Shelter.

Please note that we do not want you to feel pressured to buy the specific items from these registries, but that the items listed reflect what we need most and continually. If you would rather purchase the same item from one of the registries from a different store, please feel free. Please note also that we prefer to pick items up from the store or from you personally.
