### Cocoon Shelter Volunteer Advocacy Training



The Cocoon Shelter Volunteer Advocacy Training is an intense 50-

hour class that prepares volunteers to attend to the needs of victims of domestic violence by providing crisis intervention and conducting intakes into safe shelter. This volunteer opportunity is a fantastic way to unite with the Cocoon Shelter in providing safety, healing, and justice for battered women and their children.

The Cocoon Shelter only exists due to the generous outpouring of community support and we have been privileged to have a number of dedicated men who have volunteered in a variety of capacities. Due to procedural restructuring, we are now able to accept applications from both women and men who are interested in being a Volunteer Advocate. All applicants must go through an application and interview process. More information about The Cocoon Shelter and volunteer applications are available at www.cocoonshelter.org. For questions and to receive an application by mail, call our business line: (419) 373-1730 and leave a mailing address. Applications must be received by September 1<sup>st</sup>.

Upon completing the training, Volunteer Advocates must be able to make a one-year commitment of at least three shifts a month, including one weekend. The Cocoon Shelter Volunteer Advocacy Training will be held weekly beginning the week of September 10<sup>th</sup> and will continue through December. *Please note that completion of the Advocacy Training is required for any student who would like to be considered for an internship with the Cocoon Shelter.*

#### "Rising from the Ashes": Report from the national AAUW convention in Phoenix, Arizona

Having spent a week in Phoenix at the national AAUW convention, I can assure all of you that AAUW is NOT dying, this despite the use of the phoenix bird as the symbol for the future of our organization! I



will conced, however, that Phoenix, Arizona, in late June was HOT enough to reduce us all to ashes!

What did I learn from my week among some of the brightest women in the U.S.? Lots, but I'll FOCUS on just one:

AAUW is poised to become the organization of choice for women in the 21st century, but to do that we must be focused on what we do best. There was much discussion and debate over the role of AAUW in lives of women and girls and what the Association's goals, *our* goals as members, should be. When the dust had settled, we reconfirmed that we are an organization that has always focused on *education* as the best solution to achieving equity for us. Our membership in AAUW allows us to have a voice on a national scale as part of collaborations with other organizations, those with particular expertise in areas that we may have an interest in, but which is their focus. We leave it to groups like Planned Parenthood and the National

Organization for Women to be advocates for privacy in decision making about what goes on in our bodies or the National Association of Women Athletes to make sure that Title IX is not further eroded. We support the work of these groups, but will allow them to take the lead on legislation and advocacy in their particular areas of expertise. We, as the American Association of University Women, will do what we do best: take the lead on matters related to education and equity in the workplace, and we will do that through advocacy, education, and research, our new focused action priorities.

One particular highlight of the week was the opportunity to hear New York Times bestselling author Greg Mortenson talk about his work over the past 10 years building schools for girls in Pakistan and Afghanistan, a tale told in his book, Three Cups of Tea. If you want to be inspired and reminded about why educating women and girls is critical to the future of this world, grab a copy of this book, sit down and read it. I promise that you will find it to be an astonishing tale about a man who wanted to honor his younger sister and how that desire was manifest in his efforts to educate females in the heart of Taliban country. Mr. Mortenson has it right, I think, when he says that when you educate a boy, you educate a person, but when you educate a girl, you change a village. If we truly care about a better life for this world's people, then as AAUW members we must focus our vision, focus our organization, and focus our actions.

Oh, by the way, Greg Mortenson has been a duespaying, long-time member of the Missoula, Montana AAUW branch (a branch led for years by a BGSU alum)! He gets it. Now for our part, we must make sure that we do the necessary work so that others get it!

AAUW saw extensive press coverage during the month of June, true testament to the

visibility and strength of the organization at this exciting time. Here are some highlights:

#### **The New York Times**

A June 20th New York Times story about sexual abuse in schools cites statistics from AAUW's Hostile Hallways report:

One 2000 study, by the American Association of University Women, a nonprofit membership group, and the market research firm Harris Interactive, asked a national sample of 2,064 boys and girls in the 8th through 11th grades if they had ever experienced "unwanted and unwelcome sexual conduct," either verbal or physical, from teachers or school employees. A previous study in 1993 included an identically worded question. The response was consistent in both surveys, with about 10 percent of both boys and girls saying they had.

#### **USA TODAY**

On June 13, the AAUW Congressional Voting Record was recognized in USA TODAY. The story was about a Yale researcher, who found that male congressmen with daughters are more likely to support women's issues than those without daughters. AAUW's voting record is highlighted:

Her new analysis included congressional votes through 2004 and added information from another group: the **American Association of University Women**. She again found voting record support for a daughter-to-father influence.

#### Women's eNews

A Women's eNews story, prompted by the anniversary of Title IX, highlights a variety of Title IX cases. Six AAUW Legal Advocacy Fund supported plaintiffs are named in the story. AAUW Director of Public Policy and Government Relations Lisa Maatz is quoted about AAUW's recent research report, and the AAUW Legal Advocacy Fund is cited as a resource:

"There's always been the assumption if you get education, you will earn more and that's true, but at the same time for women, education alone doesn't overcome discrimination. Women are still judged, and penalized, on biased assumptions about their career goals, possibility of motherhood and caregiving."

#### Glamour Magazine

Glamour Magazine features AAUW's *Behind the Pay Gap* on page 124 of the July 2007 issue (Katherine Heigl on cover). The story, "Don't Let a Guy Outearn you at Work," quotes AAUW Director of Research Catherine Hill.

One year out of college, women earn only 80 percent of what their male colleagues do, according to a recent headline-grabbing story by the American Association of University Women. This annoying pattern holds true across industries, except for a handful of ones...ten years out, women make just 69 percent of what men do. "Discrimination still plays a role," contends Catherine Hill, the lead researcher on the study.

#### I EXercise My Rights Campaign

I EXercise My Rights is a public service, informational campaign designed to educate the public about Title IX. For the 35th anniversary of Title IX, the website is sharing 35 Title IX stories and eight AAUW Legal Advocacy Fund cases are included. Visit the campaign website to read the plaintiffs' stories. The registries are at the following stores:

- Target: the Cocoon Shelter has a wish list through Target, which is slightly different than a registry. You can access the wish list on-line at target.com, or at the store at the kiosks located near the entrance. We are listed under first name Cocoon, last name Shelter.
- 2. Home Depot: the registry at the Home Depot is only available on-line. We are listed under first name Cocoon, last name Shelter.
- 3. Elder Beerman: the registry at Elder Beerman is available both on-line at elder-beerman.com, and in the store. We are listed under first name Cocoon, last name Shelter.
- 4. Meijer: the registry at Meijer can be viewed online or in the store. We are listed under first name Cocoon, last name Shelter.
