





### Message from the BG Branch President

Advancing equity for women and girls through advocacy, education and research is the mission of AAUW and the focus of the BG Branch's mission based programming. Being involved in public policy is essential to our Branch's goal to promote equity and education for all women and girls. Responsible public participation is the key to our success. Participation can be achieved through individual and collective issue advocacy. We must continue being knowledgeable and aware of the current status of important issues. AAUW divides issues into four major categories: civil rights, economic security, education and Title IX.

• AAUW advocates equality, individual rights, and social justice for a diverse society and

• AAUW advocates for all women to achieve economic self-sufficiency.

• AAUW supports a strong system of public education that promotes gender fairness, equity, and diversity.

AAUW supports vigorous enforcement of Title IX and all other civil rights laws pertaining to education (http//: www.AAUW.org).

When we look at vigorous enforcement of Title IX and other civil rights laws, we should be concerned with equity in school athletics, sexual harassment and single-sex education. The American Association of University Women believes that ensuring and increasing access to educational opportunities for all women and girls is imperative to helping them obtain financial security and economic independence. To advance this goal, AAUW's 2007-09 Public Policy Program Biennial Action Priorities remind us that AAUW advocates vigorous enforcement of Title IX and all other civil rights laws. One of the major problems at every level of education in America is sexual harassment. Sexual harassment interferes with ensuring and increasing access to educational opportunities for everyone.

There are several AAUW publications based on AAUW funded research through the Educational Foundation. Four such publications are:

Drawing the Line: Sexual Harassment on Campus describes the findings from a survey of undergraduate college students. Overall, this report helps us understand how college stu-

dents perceive, experience, and respond to sexual harassment. It also provides information for creating a campus climate that is free from bias and harassment.

<u>Harassment-Free Hallways</u> is an informative, concise, and action-oriented collection of work on harassment in schools.

<u>Hostile Hallways</u> finds that sexual harassment is widespread in schools. Sexual harassment has broad consequences that are both subtle and direct on the education for girls and boys.

The official release of LAF's newest research

report, which is scheduled for publication this fall. This report examines complaints of sexual harassment filed with the Department of Education's Office for Civil Rights (OCR) by university students. Studies on the issue and OCR's response to these complaints are included in this new publication,

# Kathy Buckley entertains and inspires BGSU

Thanks to the support of several organizations, including AAUW, Comedienne Kathy Buckley inspired a large audience of students and faculty members in the Bowen-Thompson Student Union Ballroom Friday, October 12. Buckley, who is hearing-impaired, told her stories of adversity with a comic twist. As laughter filled the room, the audience learned about Buckley's hearing loss and its profound impact on her life. She also told of sev-

eral attempts to commit suicide in her teenage years. At age 20, a lifeguard jeep struck her while she was resting on the beach. She was told she would never walk again. She spent two years in a wheelchair and it took her five years to recover. In her late twenties, Buckley fought cervical cancer, not once, but twice. Based on her personal experiences, Buckley gave advice to her audience. "I spent my whole life listening to the labels of society, and that I wasn't acceptable," Buckley said. According to Buckley, that made her question her ability to achieve for a long time. Her point: do not judge others and do not let the judgment of others interfere with your success. Buckley also said communication is a key to all relationships. "Nothing is wrong with having hearing loss, but there is definitely something wrong with not being able to communicate," Buckley said.
