## Message from the BG Branch President

As we all know, AAUW advances equity for women and girls through advocacy, education, and research. This may be our mission, but what are we doing in Bowling Green, Ohio to advance equity? We are doing a lot. I believe we are thinking about the future in our efforts. *It's not just about where we are today, it's about where we want to be tomorrow.* Change and advocacy take time.

At the beginning of the year, we published the Bowling Green Action Plan for 2007-2009. In that plan we set forth five goals to:

- Increase membership to 100 members and engage the membership in opportunities for mission focused advocacy, education and research.
- Provide opportunities for organization and community leadership development within the Board and among the membership.
- Increase positive visibility of the Branch.
- Focus on diversity through membership recruitment, programming, interest groups and community engagement activities.
- Work individually and collectively to effect positive societal change.

All of these goals were set to help us advance equity and accomplish our mission. We are moving forward on all these goals. Our membership, including undergraduate student members, is 104 strong. Membership is diverse as to age, programming interests and community engagement activities. Many new faces are stepping up and taking leadership roles along with promoting the mission for AAUW with strong mentoring from established members. We are mission focused in our programming and community engaged in advocacy and education. What an awesome Branch!

The goal we will focus on this month is increasing positive visibility for the Branch in the local community. One of our strategies for increasing visibility for the Branch was through expansion of collaborations with other community groups with similar goals. Groups such as BG Zonta Club, League of Women Voters, Cocoon Shelter, BGSU Women's Center, BGSU's Student Money Management Office, BGSU Center for Multicultural and Academic Initiatives, BGSU Center for International Programs, campus student groups and the like are groups that we can and are co-sponsor community events which support the AAUW mission.

As we work on public policy programs, we are building on the work of AAUW and building upon a century of responsible public participation are already in place. Issue advocacy isn't just about AAUW lending its name to an issue or speaking up on Capitol Hill. Issue advocacy is about AAUW members and all citizens concerned with equality and being knowledgeable and aware of the current status of important issues. Strong partnerships are essential as we work on national and local issues. Partnerships are so important because we live in a time when there is a more optimistic view about capacity building, sustainable communities and social capital. The real opportunity in the work on partnerships is to find new and effective ways for each of us whether from the business, nonprofit, education or government sectors to make our distinctive contributions. Nationally, the attention being given to partnerships might legitimately be seen as part of the process of rethinking and reworking how we affect change and participate in policy advocacy. I think through our partnership building in Bowling Green we can facilitate collective action.

AAUW FOCUS

I see the partnership activities this fall as being successful and moving toward greater visibility and a good use of social capital. So what have we accomplished so far?

- We were one of the co-sponsors on October 12, 2007 for comedian Kathy Buckley's presentations on **Embracing Diversity**. Both sessions were well attended and those in attendance were challenged to rethink and reevaluate reactions and views on diversity.
- 2. We were one of the co-sponsors on October 15, 2007 for the **Women Center's Silent Witness Program**. Many of you assisted and were readers in the program. What a powerful program and a reinforcement of how we must be involved with policy change in the area of domestic violence.
- 3. We were one of the co-sponsors with the League of Women Voters on October 27, 2007 for the Candidate's Forum. Many of you participated in being informed about the local candidates. Public policy can only be changed if we are informed and then take action.
- 4. We were a silent auction sponsor on November 3, 2007 for the 3<sup>rd</sup> Annual Cocoon Shelter Benefit Dinner. Not only did we assist with fundraising but many of the local members were part of the special events planning committee for the event. Several members were in attendance at the event or supported the Shelter through personal donations.
- 5. We were one of the co-sponsors with BGSU's Student Money Management Services on November 8, 2007 for the Smart Money Workshop. This workshop informed local teachers how to help high school students understand personal finance. We assisted with welcome, registration and door prices. A display was set up about AAUW and several candidates for membership were identified.
- 6. We initiated the Public Forum on Domestic Violence: Opportunities and Challenges on November 13, 2007 and cosponsored it with BG Zonta Club and Phi Upsilon Omicron Honor Society. This was well attended by membership from both groups but more importantly the public and media representatives were in attendance.

Through these events we were able to connect and partner with more than one hundred non-profit organizations, local businesses and corporations. Collectively, we can educate, advocate and affect public policy. What was exciting to see at all the events was AAUW members taking leadership, participating and focusing on issues each person was passionate about. We all have different interests and being 100+ strong we can address different local and national issues that we are passionate about. Through partnership building we can:

- Funnel our energy toward the common good.
- Restore confidence in our abilities to achieve desired outcomes through collective action.
- Remove barriers so that we can find effective ways to connectShare responsibility for social change.
- Share resources such as time, energy, money, expertise and information.
- Be effective, efficient, creative and heard.

## New Ohio High School Core Requirement Focus of Smart Money Workshop

The audience of 200 high school teachers was attentive and enthusiastic for the Smart Money: Helping High School Students Understand Personal Finance Conference on November 8, 2007 at Bowling Green State University. The Conference was supported by BGSU Student Money Management Services, Colleges of Education and Human Development and Business Administration, the Bowling Green Branch of AAUW and the Northwest Ohio Partnership for Economic Development. The Workshop was designed to introduce high school teachers to the new Ohio law that mandates a financial literacy course of study in high schools by 2010. The new law is the brain child of Rich Cordray, Treasurer of the State of Ohio in the cabinet of Governor Ted Strickland. The Treasurer Cordray was the keynote speaker and recounted stories of young


