Coach Roderick Jackson Speaks at BGSU

Coach Roderick Jackson spoke at BGSU on Wednesday June 19th, 2008. The title of the presentation was: *Standing Up in the Face of Adversity: The story of Coach Roderick Jackson's Journey toward a Landmark Title IX Supreme Court Decision.* The event was cosponsored by the Sport Management Faculty Fund, College of Business Administration, BG AAUW Branch and the Fund for the Study of Sport & Diversity.

The Impact of Title IX on Girls and Women in Sports

When I was a high school student (30 years ago or so), athletes were boys. Girl athletes were rare, trivialized, and to be viewed with suspicion. After all, girls' "proper" role in the world of sports was as cheerleaders. For boys.

Fast forward a couple of decades: my daughter tries out for, and makes, the high school junior varsity girls' soccer team. Her boyfriend also tries out for soccer (the boys' team), but does not make the cut. Is this turn of events a tragic blow to his delicate, emerging masculinity, as it would have been when I was their age? Is he mortified that his girlfriend has achieved an athletic goal that he has failed to achieve himself? No. To his credit—and to the credit of Title IX—his response is, "Well, I'm disappointed...but at least I'll have time to go to her games and cheer her on." In other words, he will be her cheerleader.

Perhaps the most dramatically visible impact of Title IX of the Education Amendments of 1972--the statute barring sex discrimination in educational institutions that receive federal funds—is what it has meant for college and high school athletics. Since the law's enactment, girls' and women's participation, scholarships, and share of athletics budgets have grown substantially. Furthermore, in direct refutation of anti-Title IX arguments, a new study released by the Women's Sports Foundation found that increased women's athletic participation since the inception of Title IX has NOT caused men's participation to decline. In fact, both genders have seen an increase in participation and funding since the implementation of Title IX. In other words, benefits to girls/women haven't come at the expense of boys/men.

Title IX's has changed the playing field dramatically for girls and women in sports. AAUW believes that Title IX should not be weakened, because (among other reason) expansion of athletic opportunities for girls and women repeatedly show:

- Girls thrive when they participate in sports and are less likely to get pregnant, drop out of school, do drugs, smoke, or develop mental illness.
- Girls who participate in sports develop a strong work ethic and good school habits. Graduation rates are significantly higher for female athletes (68 percent) than for female students in general (59 percent).
- Participation in sports teaches women important professional lessons that have lifelong influence. Eighty percent of women identified as key leaders in Fortune 500 companies participated in sports while growing up, and 82 percent of executive businesswomen played sports.
- Athletics can offer students a ticket to higher education, since the opportunity to play sports helps low-income students who could not otherwise pay for college.
- Organized sports provide opportunities for leadership, teamwork, and competition. Organized sports offer personal contacts with adult role models who can provide guidance and support.

So, hooray for Title IX and female athletes of all ages (and hooray for their cheerleaders, too)!

Ohio AAUW Annual State Leadership Conference Well Attended

The annual state leadership conference of AAUW, the American Association of University Women (otherwise known as the American Association for Unifying Women) was held on August 16, 2008 at Ohio Wesleyan University and was facilitated by Diane Regan, State of Ohio President. Approximately sixty women in AAUW leadership positions from branches across Ohio attended the event. Those attending from the Bowling Green Branch were Mary Lou Johnson, Diane Regan, Adriene Knight, Barbara Henry, Fiona MacKinnon and Deborah Wooldridge.

AAUW was created 150 years ago and continues as a dynamic, vital organization with over 100,000 members. The mission of AAUW is to advance equity in education and employment for women and girls and to reduce the economic, social and cultural barriers that thwart personal and professional goals. The local branches and the national organization focus on issues such as pay equity, financial literacy, family leave, reproductive rights, sexual harassment in college and the workplace, sustainable development, high school and college graduation rates, barriers hindering women and girls in education and the work place.

The leadership development program was divided into five areas of discussion that evolved from a new leadership development DVD created by the national organization: AAUW Mission, AAUW Value Promise, Leadership Development, Membership Matters, Breaking Barriers, Advocacy, Current Projects, SWOT (strengths, weaknesses, opportunities and threats) Analysis, and Conclusions.

Focus on the AAUW Mission – all members and officers should be prepared with an "elevator statement" to persuade prospective members to join the organization. Examples of the organizations' activities are most influential when persuading women to join AAUW. Always carry a few membership forms in your bag for prospective members. Timing is everything.

AAUW Value Promise – states that all members, old and new, will be actively involved in the key mission of the organization influencing societal institutions on behalf of women. In the past branches have been distracted by peripheral issues, but the new strategic mission promises that women joining the organization will have the opportunity to work to level the playing field as well as the paying field.

Leadership Development – the leadership must be "clear, compelling, constructive, and consistent in communicating and demonstrating who we are and what we stand for." President Regan suggested that within the branches "leaders share responsibilities and demonstrate authentic commitment to the mission of the organization; start early to identify and develop branch leaders; create job assignments that are smaller, easier, more flexible; and use technology, work from home, and encourage online collaboration." As many branch members as possible should be involved in leadership of some kind on behalf of women.

Membership Matters – continuing the AAUW legacy is critical for continuing the agenda of the organization. Equity has not yet been achieved in this society. AAUW suggests that members target potential members who may be friends, community leaders, and activists already working in the community. Posting fliers throughout the community brings visibility and advertises that new members are always welcome. Food is always a draw.

Breaking Barriers – Each community needs to assess the barriers that hinder women and girls. In Wood County, for example, domestic violence, literacy, and adjustment of immigrant populations are barriers to the success of women.

Advocacy – Branches can distribute AAUW research, send voter e-Cards, communicate with State and national legislators, and use women-to-women voter turn out guides to advocate for women's issues. Even though the pay equity bill passed in Congress Senator Voinovich voted against it. Members may wish to call his office (202-224-3121) and express their disappointment in his vote. We must work to place more women in elected positions at the local and national levels. Branches should designate a member to track important legislation at the local, State and national levels.

Current Projects – (a) Ohio branches of AAUW are distributing *The Little Book* to the public schools to help Ohio seniors pass the Ohio Graduation Test. The pass rate on the OGT was 21.6% until the students had *The Little Book* to help them better understand the Social Studies component of the test. (b) The National Girls Collaborative Project was initiated in the Puget Sound area and provides grants of \$1,000 from the National Science Foundation for those who can provide STEM enrichment programs for girls. At this time Khris Blair provides a very successful computer enrichment camp for girls in Wood County. The BG Branch donated \$300 for T-shirts for the girls attending the camp.

SWOT Analysis – Branches should complete a SWOT (strengths, weaknesses, opportunities, threats) analysis to better understand the internal and external environment impinging on the status of the local branch before developing the agenda for the year. A realistic appraisal will be useful in determining the direction for action that the branch wishes to undertake.

Conclusions – AAUW is realigning under the direction of Linda Hallman, the new Executive Director. This planning process will take two years to filter through branches to the national organization and back again.
